The TDD complies with the impact requirements of ICC 500 for use in horizontal surfaces of tornado or hurricane storm shelters.

The TDD design pressure per ICC 500 is 270 psf (12.9 kPa) for use with tornado shelters and 100 psf (4.788 kPa) for use with Hurricane Shelters. The design wind speed relative to this shall be determined per ICC 500 Section 304 based on the parameters noted therein.

- Solatube International Inc. TDDs are manufactured under a quality control program with inspections by ICC-FS.






FIGURE 2 – SOLATUBE INSTALLATION – S750DS-C-DPI-FC-CCI-EXX-E-TP-L2P Tubular Daylighting Device (TDD)




FIGURE 3 – SOLATUBE INSTALLATION – S750DS-C-DPI-FC-CCI-EXX-E-TM-L2P Tubular Daylighting Device (TDD)
